This motion carried unanimously.

This motion carried unanimously.

Mr. Bosco moved, seconded by Mr. Poche to grant a "Letter of No Objection" to this request, per the requirements and prohibitions set forth in the Letters of No Objection of USACE dated August 13, 2012 and CPRA dated August 17, 2012 and reaffirmed by PLD. This motion carried unanimously.

#### PRESIDENT'S REMARKS

President Wilson then went over the committee assignments.

#### **OLD BUSINESS**

At this time, Mr. Poirrier addressed the Board and explained that PLD had previously approved PLD's cost of \$160,000.00 for the St. James Parish Master Plan and stated that authorization to move forward and allow President Wilson to sign said cooperative endeavor agreement was necessary. At this time, Mr. Delaune moved, seconded by Ms. Fredlund to add this matter to the agenda. Motion to add carried unanimously. Mr. Poche then moved, seconded by Mr. Delaune to allow PLD President Wilson to move forward and sign Cooperative Endeavor Agreement with the one (1) time payment of \$160,000.00 by PLD. This motion carried unanimously.

#### **NEW BUSINESS**

Under new business, Mr. Delaune moved, seconded by Mr. Poche to authorize Steven C. Wilson to sign any and all documents and agreements, at a future date, on behalf of the Pontchartrain Levee District to purchase fill material from Bear Industries, Inc. for the construction of the Mississippi River East Bank Levee, Manchac Bend Levee Enlargement and Slope Pavement Project in East Baton Rouge and Iberville Parishes, Louisiana. Discussion was had relative to PLD's costs associated with said project. The Executive Director explained that PLD's portion would be approximately 1 million dollars. Mr. Savoy questioned the cost of the fill material. The Executive Director stated it was a negotiated and confidential amount. More discussion was had. President Wilson stated that approximate cost to PLD would be close to 1 million dollars of the 8 million dollar project. Mr. Wilson advised that the Corps meeting was scheduled for August 23, 2012 to finalize the design plan. Following more discussion, motion passed unanimously.
