Vice-President Webb Harelson called the meeting to order at 6:04 p.m. The following members were present: Messrs. Jesse Bartley, Tony Cunningham*, Mike Delaune, Bill Addison, Marty Poche, Allen St. Pierre and Webb Harelson. Absent were President Steve Wilson and Jerry Savoy. (*Absent for roll call.)

Pontchartrain Levee District employees in attendance were: Messrs. Monica Salins - Executive Director, Dwight Poirrier - PLD Attorney, Kenny Steib – Levee Operations Superintendent (Detailed) Norris Melancon – Levee Operations Superintendent (Detailed) and Susan M. Sheets - Secretary to the Board. Also in attendance were: Joe Sevario – Executive Assistant to the Board, Clinton Rouyea – External Accountant and Jimmy Smith - Maintenance Consultant. Special guests included: Les Waguespack and Hamid Alizahad of Shaw Coastal, Henry Picard of Burk-Kleinpeter, Misty Evans of LA DOTD, Bert Gamble of Rio Bravo, Jay LeBlanc, Robert Hoover of COPR, Ronnie Brown of SMH Capital, Jake Lambert of GSA, Charlie Raymond and David Roger of Taggard Morton and Nathan Junius of Linfield Hunter & Junius.

The Pledge of Allegiance was recited.

A motion to approve the minutes of the Regular Board Meeting of January 20, 2009 was offered by Jesse Bartley, seconded by Marty Poche and unanimously carried.

At this time, Mr. Bartley moved to go into Executive Session for approximately one (1) hour to discuss legal matters. This motion was seconded by Mr. St. Pierre seconded this motion and it carried unanimously. Executive Session began at approximately 6:08 p.m. *Mr. Cunningham arrived at 6:10 p.m. and took his seat. At 7:00 p.m., Bartley moved, seconded by Mr. Poche to return to regular session. Motion carried unanimously. During Executive Session, legal matters were discussed but no action was taken at this time. Mr. Bartley moved to add an item to the agenda regarding an update and status report regarding investments. This motion to add this discussion was seconded by Mr. Addison and carried unanimously. Mr. Bartley then called on Mr. Brown who provided members with a copy of the investment reports. Discussion was had relative to options and strategies. Mr. Brown updated members as to the most recent portfolios as well as discussion concerning the market. Discussion continued. Members thanked Mr. Brown for the update.

COMMITTEE REPORTS

Finance Committee: Mr. Jesse Bartley reported on the Finance meeting held on February 10, 2009. Mr. Poche moved, seconded by Mr. Delaune to approve regular monthly invoices in the amount of \$21,618.53 as recommended by committee. The motion carried unanimously. Mr. Bartley moved, seconded by Mr. Delaune to approve payment in the amount of \$3,753.09 to G.C.R. & Associates for FEMA Claims Work as recommended by committee. The motion carried unanimously. Mr. St. Pierre then moved, seconded by Mr. Poche to approve the new By-Laws as amended and recommended by committee. This motion carried unanimously. Next, Mr. Delaune moved, seconded by Mr. Poche to approve the expenses associated with the National Hurricane Conference to be held on April 6 - 10, 2009 in Austin, Texas. This motion carried unanimously Next, Mr. Bartley moved, seconded by Mr. Poche to approve the expenses associated with the Annual Association of Levee Boards of Louisiana Workshop to be held May 7-8, 2009 in Baton Rouge. This motion carried unanimously. Mr. Bartley moved, seconded by Mr. Addison to approve the expenses regarding the Mississippi River Freshwater Diversion Summit to be held on March 3-5, 2009 in New Orleans, Louisiana as recommended by committee. This motion also carried unanimously. Lastly, Mr. St. Pierre moved to amend the Board Attorney's contract concerning approval of payment on a monthly basis and invoice shall be approved by the Board of Commissioners along with the regular monthly invoices as recommended by committee. This motion was seconded by Mr. Addison and also carried unanimously.

Equipment Committee: Mr. Addison reported on the meeting held on February 10, 2009. Mr. Addison moved to approve the lowest quote meeting specifications, Michel's Electric regarding new lighting for he PLD Headquarters in the amount of \$5,880.00. This motion was seconded by Mr. Bartley and carried unanimously. Mr. Addison moved, seconded by Mr. Delaune to approve to install the Kirshner Blades for two (2) PLD Dozers at a total cost of \$3,667.00 as recommended by committee. This motion carried unanimously.

Security/Safety Committee: Mr. Mike Delaune reported on the security meeting held on February 12, 2009. Mr. Poche moved to approve the purchase of seven (7) Glock 22 .40 Caliber handguns, including holsters, ammunition and web gear for the PLD Police Department at a cost estimate of approximately \$7,000.00. This motion was seconded by Mr. Addison and carried unanimously. Mr. Delaune then moved, seconded by Mr. St. Pierre to approve the renovations/improvements for a separate office for the PLD Police Captain to the rear of the EOC area, cost estimated to be approximately \$3,000.00. The motion carried unanimously. Next, Mr. Bartley moved to approve the purchase of new PLD Police Officer uniforms at a cost of approximately \$5,800.00. This motion was seconded by Mr. Addison and also carried unanimously. Mr. Bartley moved to approve the purchase of mobile and portable radios for the emergency response personnel to include seven (7) Motorola XTL 2500, 700/800 MHz mobile radios at an estimated cost of \$3,500.00 each and fifteen (15) Motorola XTS 2500 700/800 MHz portable radios at a cost of \$2,396.00 each, to include programming and installation fees associated with all of these radios, for a total cost estimated to be approximately \$62,500.00 as recommended by committee. This motion was seconded by Mr. Delaune and also carried unanimously. At this time, Mr. Delaune moved to add an item to the agenda for discussion concerning a replacement PLD police unit. This motion to add was seconded by Mr. Poche and carried unanimously. Discussion was had relative to replacing PLD Police Truck #12 which had over 150,000 miles. Following brief discussion, Mr. Delaune moved, seconded by Mr. Poche to purchase the truck in the amount of \$25,600 which was in the 2008/2009 budget under state contract.

Personnel Committee: Mr. Cunningham reported on the personnel meeting held on February 12, 2009. Mr. Poche moved, seconded by Mr. St. Pierre to approve the merit increases for March 2009 for eligible employees' number: #1485, #126518, #126539, and #126436. The motion carried unanimously.

STAFF REPORTS

Mr. Cunningham gave the update relative to the Hurricane and Flood Control Projects due to Ms. Nosari's absence. Mr. Bartley moved, seconded by Mr. Delaune to add an item to the agenda regarding an update concerning the Laurel Ridge Project. The motion carried unanimously. Mr. Jake Lambert of GSA Engineering then gave an update on said project.

LaBure to the Pontchartrain Levee District for right-of-entry for a period of 24 months beginning August 25, 2008 and ending August 24, 2010 to conduct surveys, soil borings, environmental and cultural resources investigations, and HTRW investigations in connection with the Mississippi River, East Bank Levee, B/L station 180+00 to B/L station 208+00, East Baton Rouge Parish, Louisiana. The limits of work are indicated on the enclosed map entitled "Mississippi River, East Bank Levee, Pontchartrain Levee District, East Baton Rouge Parish, Louisiana, sheet identification number X-01, dated July 31, 2008. This right of entry was approved at the August 18, 2008. A modification to this original request was submitted to install piezometers. The piezometers would be installed between the ditch and the landside toe of the levee. They would be installed by a Corps contractor. There could be as many as 5 piezometers as new laws may preclude possibility of putting piezometers with different tip elevations in the same hole. We would like these piezometers to remain in place until we can get some high water readings so they could be in place for a long time, say 5 years, the Corps would be responsible for maintenance, monitoring, and replacement. The piezometers will consist of a riser pipe, most likely PVC, with a piezometer tip at the end set in sand at desired elevation in aquifer, above the sand a bentonite plug will be set, then remainder of annulus to ground surface will be grouted similar to a normal boring. A water well installation report would be furnished to DOTD and PLD with particulars on each piezometer. Mr. Delaune moved, seconded by Mr. Addison to grant right of entry as requested. This motion carried unanimously.

Department of the Army, Corps of Engineers, New Orleans District – to extend the 90 day right of entry dated June 12, 2008 and previously approved at the PLD Board Meeting in June of 2008 for the Gulf South Pipeline Gap Closure, and a second extension of 90 days which was approved at the PLD Board Meeting in September of 2008, and the request for a third extension of 120 days, at Baseline Station 283+90 to 293+50, in St Charles Parish, Louisiana. Mr. Bartley moved, seconded by Mr. St. Pierre to grant right of entry as requested. This motion carried unanimously.

Vice President Harelson had no remarks.

The only item under old business was to approve the invoice from Board Attorney. Mr. Delaune questioned a bill submitted by Mr. Robert. Following brief discussion, Mr. Bartley moved, seconded by Mr. Poche to approve invoice from Board Attorney, Dwight Poirrier in the amount of \$3,644.98. The motion carried unanimously.

Mr. Harelson asked members to review the budget explanation and draft budget for adoption next month.

At this time, Mr. Delaune moved, seconded by Mr. Addison to adjourn. The motion carried unanimously and President Wilson declared the meeting adjourned at 7:50 p.m.
