President Steve Wilson called the meeting to order at 6:02 p.m. The following members were present: Messrs. Steve Wilson, Mike Delaune, Marty Poche, L.C. Irvin, Allen St. Pierre and Ms. Alice Fredlund. Absent were: Jerry Savoy and Ricky Bosco.

Pontchartrain Levee District employees in attendance were: Monica Salins – Executive Director, Dean Smith – Police Captain and Susan M. Sheets - Secretary to the Board. Also in attendance was: Dwight Poirrier – PLD Legal Counsel, Clinton Rouyea – External Accountant and Joe Sevario – Executive Assistant to the Board. Special guest included: A.J. Ms. Fredlund then moved, seconded by Mr. Irvin to approve the minutes of the regular board meeting of October 15, 2012. This motion also carried unanimously.

COMMITTEE REPORTS

Security/Safety Committee: Mr. Mike Delaune reported on the security meeting held on November 13, 2012. Mr. St. Pierre moved, seconded by Ms. Fredlund to approve the Intergovernmental Agreement between the Pontchartrain Levee District and the Port of South Louisiana to authorize PLD President, Steve Wilson, to execute and proceed with said agreement for 24 hour dispatching services for the PLD Police Department for a term of one (1) year, payment for said service will be made on a quarterly basis as recommended by committee. The motion carried unanimously. Mr. Irvin moved to promote Roscoe Brewer to the vacant Lieutenant position of the PLD Police Department and that Lieutenant Brewer serve a nine (9) month probationary period beginning November 19, 2012, as recommended by committee. This motion carried unanimously.

Equipment Committee: Mr. Marty Poche reported on the meeting held on November 13, 2012. Mr. St. Pierre moved, seconded by Mr. Irvin to approve the quote and proceed with purchase from Bobcat, a root grapple and fork system, in the amount of \$3,649.10 as recommended by committee. This motion carried unanimously.

Mr. St. Pierre moved, seconded by Mr. Poche to approve to amend the contract with Moffatt & Nichol for the levee shoreline enhancement and protection project to provide construction oversight for the project as set forth and requested in the amount of \$47,000.00 and authorize LD President, Steve Wilson, to execute said amendment, as recommended by committee. This motion carried unanimously. Mr. Poche moved, seconded by Mr. Irvin to approve and authorize PLD President, Steve Wilson, to execute the Cooperative Endeavor Agreement between the PLD and City of St. Gabriel specific to the bike path as recommended by committee. This motion also carried unanimously. Mr. Delaune moved, seconded by Mr. Poche to approve and authorize PLD President, Steve Wilson, to execute and move forward with the contract for Emergency Operation and Maintenance Services for the Cross Bayou Pump Station between the Board of Commissioners for the Pontchartrain Levee District and BLD Services, L.L.C., as recommended by committee. The motion carried unanimously. Mr. St. Pierre then moved to approve and authorize PLD President, Steve Wilson, to execute and move forward with the contract for Inspection, Operation and Maintenance of the Cross Bayou Pump Station between the Board of Commissioners for the Pontchartrain Levee District and BLD Services, L.L.C. as recommended by committee. This motion was seconded by Mr. Delaune and carried unanimously. Mr. Delaune moved, seconded by Mr. Irvin to approve to amend the Laurel Ridge contract amount and authorize payment for the additional \$41,175.75 as requested and to authorize PLD President, Steve Wilson, to execute said amendment as recommended by committee. This motion carried unanimously. Mr. Poche moved to approve the regular monthly invoices in the amount of \$74,568.54 as recommended by committee. This motion was seconded by Mr. Delaune and carried unanimously. Mr. Delaune moved, seconded by Mr. Poche to approve the invoice from G.C.R. and Associates for the St. Charles Parish Hurricane Protection 100 year protection in the amount of \$10,372.20 for the month of October 1, 2012 through October 31, 2012 as recommended by committee. This motion carried unanimously. Mr. Delaune moved, seconded by Mr. Irvin to approve the invoice from GCR & Associates in the amount of \$830.82 for computer technical support for the month of September 2012, as recommended by committee. Motion carried unanimously.
