Once said modifications had been made and satisfied by all parties, then same will be released.

NEW BUSINESS

At this time, Mr. Savoy questioned the hauling going on out at the Bonnet Carre' Spillway in St. Charles Parish. Brief discussion was had.

PUBLIC COMMENTS

Under public comments, Ms. Fredlund briefly discussed the recent outdoor concert held at the new L'Auberge Casino in Baton Rouge, LA and stated that the levee looked fine after the concert. Ms. Fredlund then discussed an area upriver from the casino where there seems to be a 'make do' ramp which was very unacceptable and it seems that dredgers and hay farmers were rutting the toe of the levee rather than using a designated ramp. Discussion was had. Lt. Brewer would investigate said area.
