WHEREAS, southeast Louisiana has twice in recent history suffered catastrophic loss of life, property damage and economic devastation due to flooding, first by Hurricane Betsy in 1965, and again on a far greater scale in 2005 by Hurricane Katrina; and

WHEREAS, in response to the devastation caused by Hurricane Katrina, the U.S. Congress authorized and appropriated funding for the U.S. Army Corps of Engineers (USACE) to design and construct the Greater New Orleans Hurricane and Storm Damage Risk Reduction System (HSDRRS) to strengthen and provide 100-year level of protection capable of withstanding the efforts of a storm having a one percent chance of occurring each year; and

WHEREAS, the failures of the flood protection system constructed subsequent to Hurricane Betsy that occurred during Hurricane Katrina demonstrated the critical importance for the system to be robust and resilient; and

WHEREAS, the U.S. Congress in the Fourth and Sixth Supplemental Appropriations provided funding to armor the critical elements of the HSDRRS to provide the resiliency required for the system to maintain its functionality even when subjected to forces greater than its intended design level; and

WHEREAS, the USACE provided the results of its alternative evaluation process and its recommended alternative to armor the HSDRRS to the State of Louisiana (the Non-Federal Sponsor) on June 6, 2011; and

WHEREAS, the State of Louisiana provided a written response to the USACE on June 24, 2011, expressing its disagreement with the materials and methodologies recommended by the USACE and recommending that additional alternatives be considered and evaluated; and

WHEREAS, the ability of local authorities to financially and physically operate and maintain the armoring is of essential importance; and

WHEREAS, the State, local flood protection authorities and levee districts have determined that more research and investigation is needed into the methodologies and materials recommended by the USACE in order to evaluate their adequacy, sustainability and economic viability for providing risk reduction under local environmental conditions, and for the results of this evaluation, along with potential alternatives, to be presented to the USACE so that the best possible, fully informed decisions can be reached; and

WHEREAS, authorities and authorizations provided under the Water Resources Development Act (WRDA) and the aforementioned supplemental appropriations do not specify a deadline for the delivery of armoring to the HSDRRS; however, the USACE has imposed a deadline of June 1, 2012, for the armoring to be put in place.

BE IT HEREBY RESOLVED, that the Pontchartrain Levee District urges and requests the U.S. Army Corps of Engineers to extend its deadline of June 1, 2012, to complete the armoring for the HSDRRS so that all methods and alternatives can be considered and evaluated and the system can be made as resilient as possible to protect the lives, property and economic welfare of the citizens of southeast Louisiana.

CE-1-3 and CE-1-4, as required by the U.S. Army Corps of Engineers for construction of the Duncan Point Seepage Berm and Road Relocation Project, East Baton Rouge Parish. The motion carried.

Mr. Savoy moved, seconded by Mr. Bosco to approve the Intergovernmental Agreement between the Pontchartrain Levee District and the Amite River Basin Water & Drainage Conservation District, as prepared by PLD Board Counsel, and to authorize the PLD President to execute said agreement for the acquisition of a 2-year temporary work area easement for borrow identified as Tract No. CE-2-1 and a 2-year temporary access road easement identified as Tract No. CE-2-2, including the right of access across the Kansas City Southern Railroad tracks and right-of-way, as required by the U.S. Army Corps of Engineers for construction of the Duncan Point Seepage Berm and Road Relocation Project, East Baton Rouge Parish. The motion carried.
